



## **Gas Protection Act Fees Effective April 1<sup>st</sup>, 2015**

### Installation Permits for Residential Premises

**1.** The following fees are payable in respect of installation permits for residential premises:

- (a) for a permit for any permanent or temporary gas fitting work, not including any connection or installation of an appliance, gas meter, propane container, service line or other gas fitting: \$66
- (b) for a permit for the installation of one appliance connection or gas outlet, in addition to the fee under item (a): \$16
- (c) for a permit to replace an existing appliance that does not require any change to an existing gas line (no fee under item (a) will be charged): \$52
- (d) for a permit for the installation of one propane container of 115 USWG or more: \$66
- (e) for a permit for the installation of one gas meter: \$66
- (f) for a permit for the installation of one underground gas service line from a distribution line or from a propane container: \$104
- (g) for a permit for the installation of any temporary gas fitting equipment not included in items (a) to (f): \$120

### Installation Permits for Non-residential Premises

**2.** The following fees are payable in respect of installation permits for non-residential premises:

- (a) for a permit for any permanent or temporary gas fitting work, not including any connection or installation of an appliance, gas meter, propane container, service line or other gas fitting work, having a combined input
  - (i) less than or equal to 117 kW (400,000 British Thermal Units) per hour: \$198
  - (ii) greater than 117 kW (400,000 British Thermal Units) per hour: \$287
- (b) for a permit for the installation of one appliance connection or gas outlet, in addition to the applicable fee under item (a): \$79
- (c) for a permit to replace an existing appliance that does not require any change to an existing gas line (no fee under item (a) will be charged): \$79
- (d) for a permit for the installation of one propane container having a volume
  - (i) less than or equal to 5,000 USWG: \$79
  - (ii) greater than 5,000 USWG: \$162
- (e) for a permit for the installation of an automotive or cylinder filling dispenser: \$120
- (f) for a permit for the installation of one gas meter: \$79



- (g) for a permit for the installation of a
  - (i) service line from a propane container or gas main: \$79
  - (ii) distribution line: \$162
  - (iii) transmission line: \$239
- (h) for a permit for the installation of any temporary gas fitting equipment not included in items (a) to (g): \$239
- (i) for a permit for the installation of a propane vehicle conversion or a propane vehicle recertification: \$79
- (j) for a permit for gas fitting work on any construction, road, exploration or mining camp, including any connection of an appliance or installation of a propane container, service line or exterior or interior gas piping: \$598
- (k) for a permit for the subsequent move of a construction, road, exploration or mining camp in the same year that the permit fee under item (j) is paid: \$179
- (l) for a permit for the installation of any gas fitting equipment on mobile road construction equipment that uses propane gas as a fuel to heat tar or any other substance: \$120

#### Re-inspections

3. The following fees are payable in respect of re-inspections:
- (a) for each hour or part of an hour for each re-inspection of any gas equipment installation or gas fitting work on a residential premises: \$98
  - (b) for each hour or part of an hour for each re-inspection of any gas equipment installation or gas fitting work on a non-residential premises: \$120

#### Registration as a Certified Gas Fitter

4. The fee payable for a certificate of registration as a certified gas fitter is \$82
