Introduction

This report presents a statistical summary of the vehicle and driver population in the Northwest Territories (NWT) as well as an overview of revenue, driver testing activity, convictions and suspensions. The information in this report is derived from data maintained on the DRIVES system.

The information is checked for reasonableness and accuracy by comparing with reports available on DRIVES and the System for Accountability and Management (SAM) as well as Northwest Territories population figures. GNWT staff also have an opportunity to review the charts and tables for accuracy. Despite these measures, errors may exist due to data coding and entry; therefore, the information should be viewed with caution.

The 2019-2020 fiscal year was a busy one. With new health and safety COVID guidelines in place, upgrades to NWT's highway system continued to be rolled out and DMV offices across the territory continued to serve clients. In Fall 2020, the GNWT released redesigned driver's licences and general identification cards and implemented new facial recognition technology.

The new cards offer improved security features, making them harder to alter or replicate, ensuring NWT residents are better protected from fraud. With the implementation of facial recognition technology, residents have greater protection from identity theft as the technology prevents people from getting several licences or ID cards in multiple jurisdictions.

In 2019-2020, the GNWT also continued to roll out its driver safety campaigns by working with local media outlets to spread awareness about bison and snowmobile safety, as well as impaired driving.

With public safety being the top priority for the GNWT, we continued to advance work on mandatory entry-level training (ELT) requirements for new Class 1 drivers (bus and truck drivers). Expected to be released in December 2021, ELT requirements will meet Canada's national standard for new Class 1, while also covering topics that are specific to driving conditions in the NWT. This mandatory training will result in more highly skilled drivers working in the truck and bus industries, increasing safety for all road users across the territory.

In addition to our efforts to improve driver safety, some improvements will also be made to the driver and vehicle website, also known as iDMV. Overall, clients can expect an improved, user-friendly online experience that will better meet their needs.

The GNWT will continue to work with road safety stakeholders and will monitor road safety issues and trends across the country to ensure we can deliver safe, secure, accessible and reliable movement of people and goods across the NWT.

Section Summaries

Section 3.0 shows the number of registered vehicles by type and region. The table includes all vehicles with a valid registration as of December 31, 2019 and registered to an individual or company with a Northwest Territories address. Duplicate registrations are excluded by counting unique vehicle identification numbers. As of December 31, 2019, there were 40,269 registered vehicles, a 0.2 percent decrease from 2018.

The breakdown of registered vehicles by type is an approximation based on variables including; vehicle make, vehicle model, vehicle type, style, license plate type, and gross vehicle weight. Light-duty vehicles, including passenger cars, passenger vans, sport utility vehicles and pickup trucks, comprised 73 percent of the vehicle population in 2019.

Section 4.0 presents the characteristics of licensed drivers. The tables include all Northwest Territories residents with a valid driver's license as of December 31, 2019. On this date, there were 26,691 licensed drivers, a 2.0 percent increase from 2018. The population of the Northwest Territories increased by 0.6 percent during the same period. Persons aged 65 and over comprised 10.2 percent of the driver population. Although not shown in the tables, the proportion of drivers aged 65 continues to increase.

Section 5.0 presents revenue data from all Driver and Vehicle Licensing Offices and Online services operated by INF and by private contractors. The revenue is summarized by category, region and Issuing Office for all transactions taking place between April 1, 2019 and March 31, 2020.

For the 2019/2020 Fiscal Year, revenue from the various categories is as follows:

- Vehicle registrations:..... \$5,618,159.00
- Driver testing:..... \$204,498.00
- Driver licensing:..... \$704,416.00
- Products and services: \$974,195.00
- **Total: \$7,501,268.00**

Section 6.0 shows the total number of driver tests conducted in the Northwest Territories between April 1, 2019 and March 31, 2020 by test type (written vs. road), class and region and shows the corresponding passing rates. In the 2019/2020 Fiscal Year 9,069 written tests and 1,799 road tests were conducted. The corresponding passing rates were 64.2 per cent and 71.7 per cent, respectively.

Section 7.0 presents information on driver convictions, suspensions and demerit points of Northwest Territories drivers. The tables showing convictions under the Criminal Code, Motor Vehicles Act and Regulations, All-Terrain Vehicles Act and municipal bylaws include convictions arising from traffic offences committed in the Northwest Territories between April 1, 2019 and March 31, 2020. The tables exclude convictions arising from offences committed outside of the Northwest Territories.

During the 2019/2020 Fiscal Year, there were 190 convictions under the Criminal Code, a 17.4 percent decrease from the previous Fiscal Year. There were 1,746 convictions under the Motor Vehicles Act. This is an 8.0 per cent decrease from 2018/2019.

Section 8.0 shows the number of permits issued by type and issuing location, number of Commercial Vehicle Safety Alliance (CVSA) inspections conducted and number of commercial transport-related convictions under the Motor Vehicles Act and Transportation of Dangerous Goods Act for the 2019/2020 Fiscal Year.

This section also includes the number of Deh Cho Bridge toll permits issued by toll class and associated revenue. During 2019/2020:

- 17,386 permits were issued;
- 685 CVSA inspections were conducted;
- There were 51 commercial transport-related convictions under the Transportation of Dangerous Goods Act and Regulations as well as under commercial transport-related regulations pursuant to the Motor Vehicles Act; and
- \$4,011,962.00 in Deh Cho Bridge toll revenue was collected between April 1, 2019 and March 31, 2020.

Section 9.0 presents a summary of reportable collisions in the Northwest Territories for the 2018 and 2019 calendar years. A reportable collision is an incident involving one or more motor vehicles resulting in death, personal injury or a minimum of \$2,000 in property damage in the absence of deaths or injuries. Details on traffic collisions are presented in the publication entitled “2019 NWT Traffic Collision Facts” and include collisions occurring on the NWT Highway system. This publication contains useful information on issues that affect collisions and their severities, such as drinking and driving; unsafe speed; young and old drivers; and use of occupant restraints. 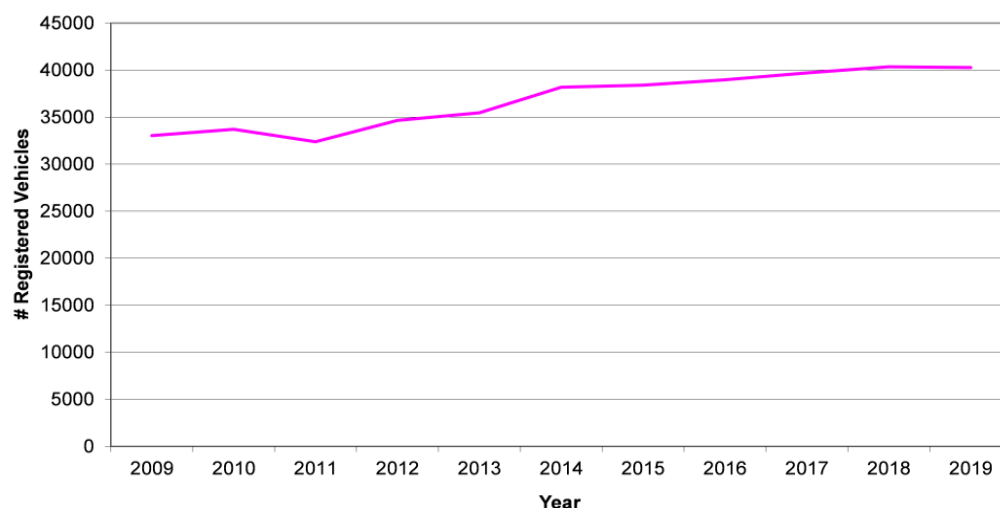

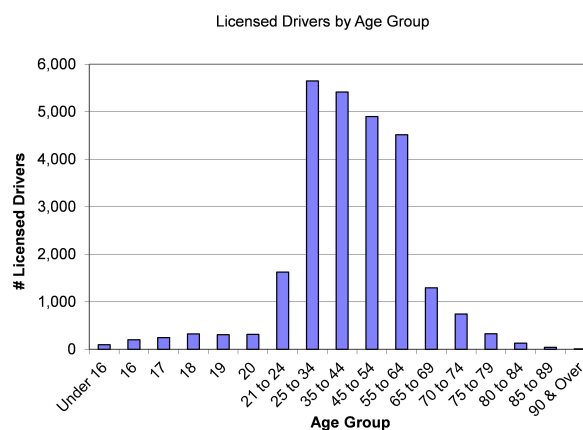

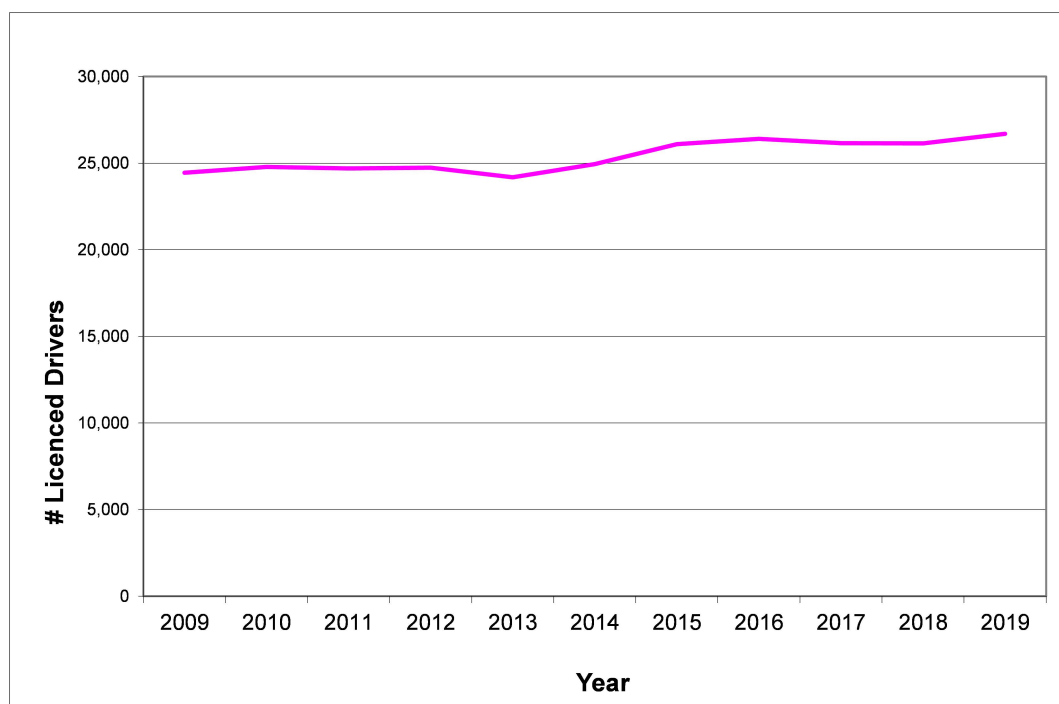

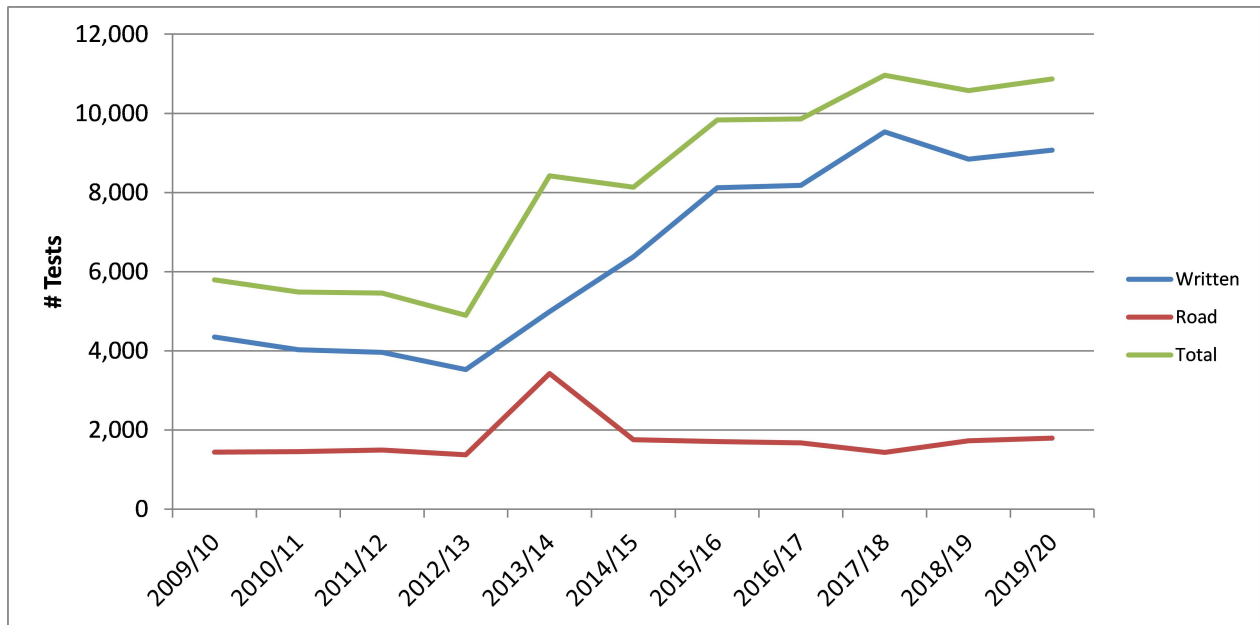

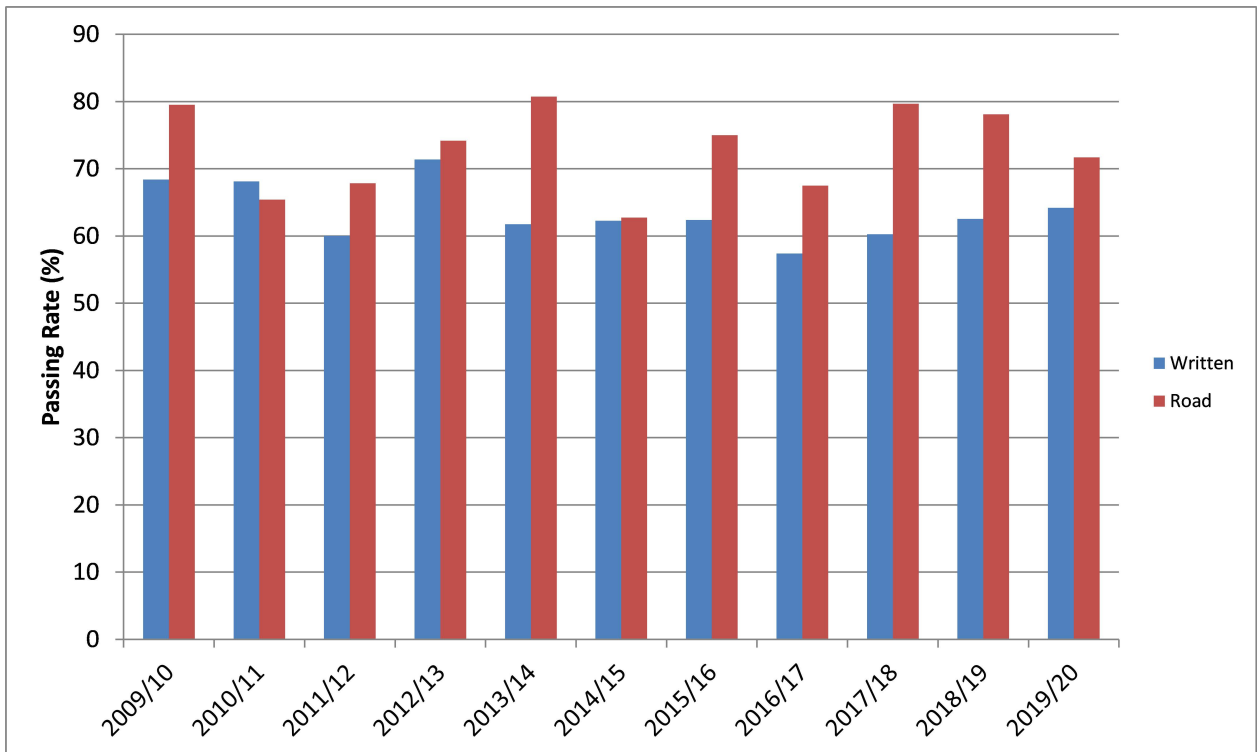

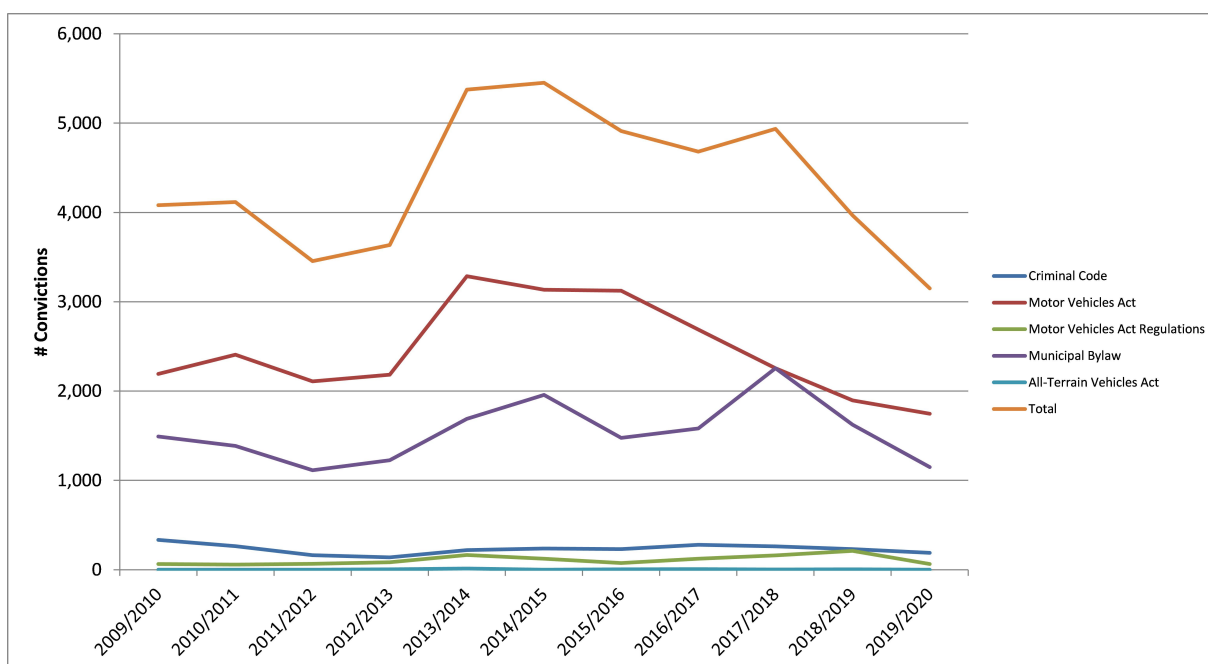

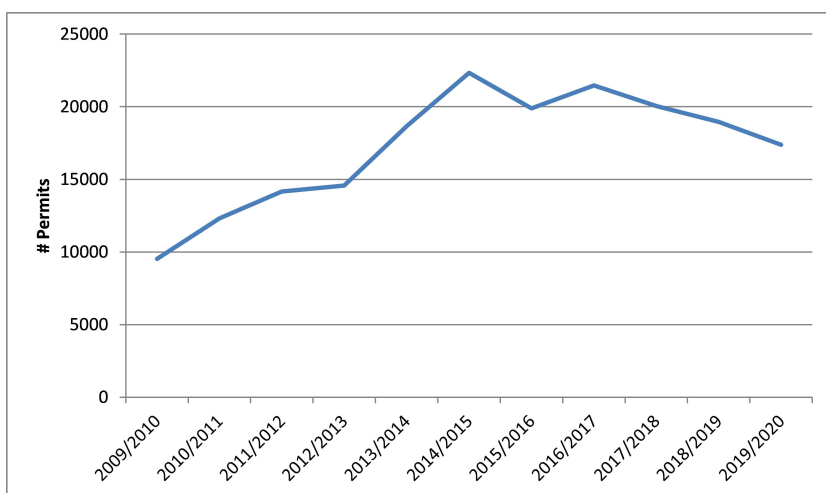

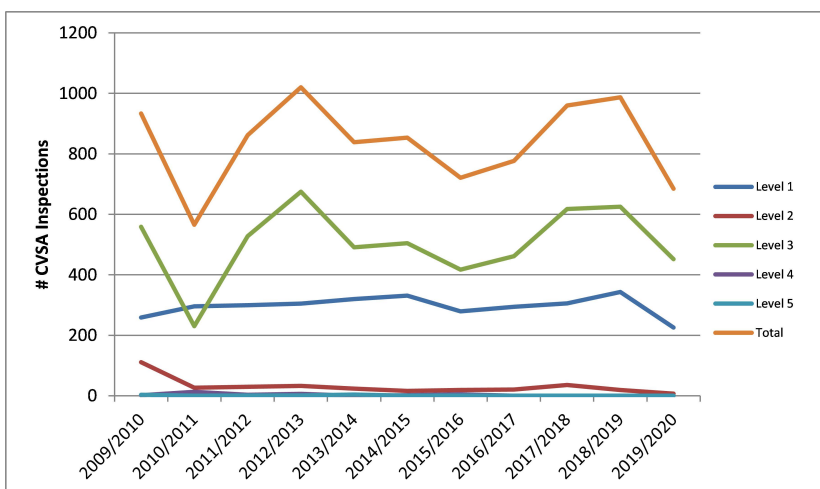

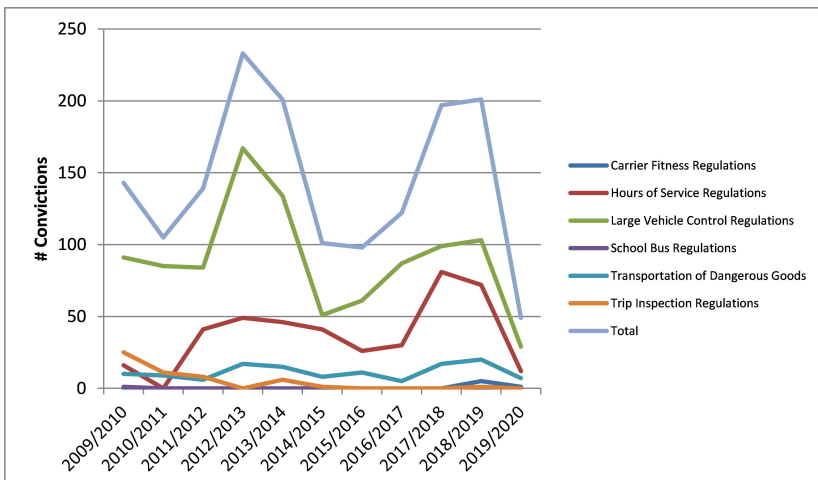
Trends in Commercial Transport Permits, 2009/2010 to 2019/2020
