Preface

The Road Licensing and Safety Division (RL&S) coordinates and leads the Department of Transportation's road licensing and regulatory responsibilities. A territory with a small population and vast geographical size poses challenges because the lack of infrastructure and cost of providing services must be balanced against the goal of improving service to all residents.

RL&S continually strives to improve driver and vehicle licensing services in all communities. The newly implemented DRIVES system has effectively replaced many of the previous Motor Vehicle Information System (MVIS) capabilities. The new Driver Profile module, slated for implementation in early 2013, will incorporate new technologies to administer an increased and enhanced suspension, restriction and demerit points program.

RL&S continues to work with other jurisdictions to ensure that our high-security Drivers License and General Identification Cards are accepted as identification anywhere in North America. We are seeking ways to improve our process for issuing these products, without compromising their security and acceptance.

The launch of the Drive Alive program pulls together a number of travel-safety campaigns in the NWT. Drive Alive works with private and government partners to achieve a simple objective—making NWT residents aware of the need to make safe choices whether they are pedestrians, passengers or operators of a vehicle or boat on our roads, trails, and waterways.

All driver manuals for NWT residents are now available free of charge on our website at www.dot.gov.nt.ca. Currently the Basic Driver's Manual is also available in French. The website is a good source of information about driver and vehicle licensing, as well as road safety initiatives that complement the Drive Alive program. We continue to look for ways to make our services and information available on-line.

Reflecting the Departments ongoing commitment to public safety, distracted driving legislation, which prohibits the use of any restricted electronic device, came into force on January 1, 2012. Under this legislation there have been 34 convictions throughout the Northwest Territories.

RL&S is targeting the Spring of 2013 to launch the new Ignition Interlock program. This program will allow drivers with impaired driving convictions to use a breath-screening device that prevents the vehicle from starting if the driver's BAC exceeds a pre-set limit. The companion *High Risk Drivers Program* (HRDP) will be launched in 2013. Modeled on best practices in Alberta and Manitoba, the HRDP will enhance public safety by implementing tougher sanctions for high-risk behavior and by imposing mandatory remedial education as required.

As always, RL&S is working in co-operation with municipal enforcement and the RCMP to coordinate enforcement activities and enhance public safety.

We welcome ideas from communities and other stakeholders as we continue our efforts to better serve the residents of the NWT.

1.0 Introduction

This report presents a statistical summary of the vehicle and driver population in the Northwest Territories and presents a summary of revenue, driver testing activity, convictions and suspensions. This information can be used by Program Managers, Regional Superintendents and Senior Managers to assess Road Licensing and Safety activities and monitor trends. The information in this report is derived from data maintained on the Road Licensing and Safety Motor Vehicle Information System (MVIS). A series of reports are used to extract the statistical information from MVIS.

The information is checked for reasonableness and accuracy by comparing with reports available on MVIS and the Financial Information System (FIS) as well as Northwest Territories population figures. Road Licensing and Safety Headquarters and Regional staff also have an opportunity to review the charts and tables for accuracy. Despite these measures, errors may exist due to data coding and entry, therefore, the information should be viewed with caution.

2.0 Executive Summary

Section 3.0 shows the number of registered vehicles by type and region. The table includes all vehicles with a valid registration as of December 31, 2011 and registered to an individual or company with a Northwest Territories address. Duplicate registrations are excluded by counting unique vehicle identification numbers. As of December 31, 2011, there were 32,391 registered vehicles, a 3.9 percent decrease from 2010.

The breakdown of registered vehicles by type is an approximation based on variables including; vehicle make, vehicle model, vehicle type, style, license plate type, and gross vehicle weight. Light-duty vehicles, including passenger cars, passenger vans, sport utility vehicles and pickup trucks, comprised 73 percent of the vehicle population in 2011.

Section 4.0 presents the characteristics of licensed drivers. The tables include all Northwest Territories residents with a valid driver's license as of December 31, 2011. On this date, there were 24,691 licensed drivers, a 0.4 percent decrease from 2010. The population of the Northwest Territories decreased by 0.2 percent during the same period. Persons aged 65 and over comprised 5.4 percent of the driver population. Although not shown in the tables, the proportion of drivers aged 65 and over is increasing.

Section 5.0 presents revenue data from all Driver and Vehicle Licensing Offices operated by the Department of Transportation and by private contractors. The revenue is summarized by category, region and Issuing Office for all transactions taking place between April 1, 2011 and March 31, 2012.

For the 2011/2012 Fiscal Year, revenue from the various categories is as follows:

- Vehicle registrations: \$3,873,990.00
- Driver testing: \$109,940.00
- Driver licensing: \$501,814.00
- Products and services: \$1,059,257.00
- Total: \$5,545,001.00

Section 6.0 shows the total number of driver tests conducted in the Northwest Territories between April 1, 2011 and March 31, 2012 by test type (written vs. road), class and region and shows the corresponding passing rates. In the 2011/2012 Fiscal Year, 3,965 written tests and 1,494 road tests were conducted. The corresponding passing rates were 60.0 percent and 67.8 percent, respectively.

Section 7.0 presents information on driver convictions, suspensions and demerit points of Northwest Territories drivers. The tables showing *Criminal Code* and *Motor Vehicles Act* convictions include convictions arising from offences committed by Northwest Territories residents between April 1, 2011 and March 31, 2012. The tables exclude convictions arising from offences committed outside of the Northwest Territories.

During the 2011/2012 Fiscal Year, there were 249 convictions under the *Criminal Code*, a 15.8 percent increase from the previous Fiscal Year. There were 1,269 convictions under the *Motor Vehicles Act*. This is a 17.0 percent decrease from the previous Fiscal Year.

Section 8.0 shows the number of permits issued by type and issuing location, number of Commercial Vehicle Safety Alliance (CVSA) inspections conducted and number of offences under the *Transportation of Dangerous Goods Act and Regulations* for the 2011/2012 Fiscal Year.

During 2011/2012

- 14,172 permits were issued;
- 862 CVSA inspections were conducted; and
- 6 charges were laid under the *Transportation of Dangerous Goods Act and Regulations*.

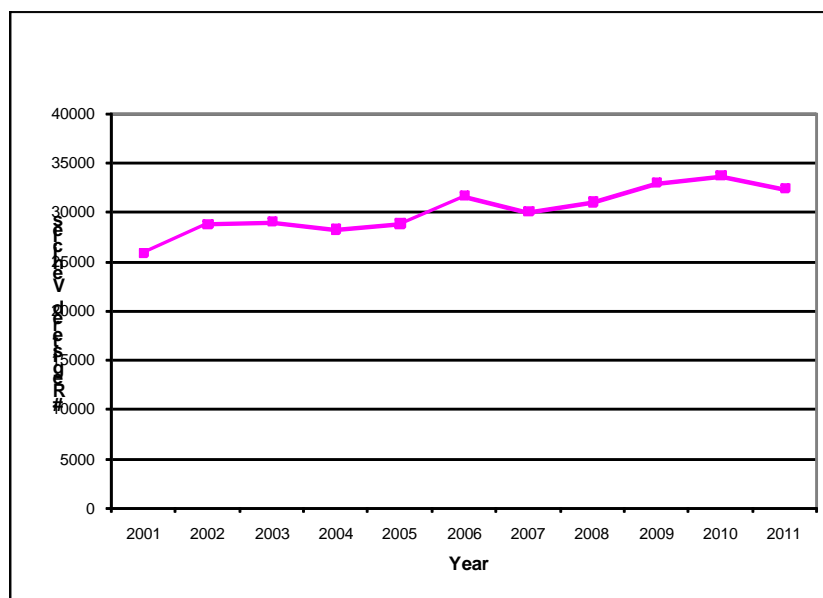
Section 9.0 presents a summary of reportable collisions in the Northwest Territories for the 2010 and 2011 calendar years. A reportable collision is an incident involving one or more motor vehicles resulting in death, personal injury or a minimum of \$1,000 in property damage. Details on traffic collisions are presented in the publication entitled “2011 NWT Traffic Collision Facts” and include collisions occurring on the NWT Highway system. This publication contains useful information on issues that affect collisions and their severities, such as drinking and driving; unsafe speed; young and old drivers; and use of occupant restraints. 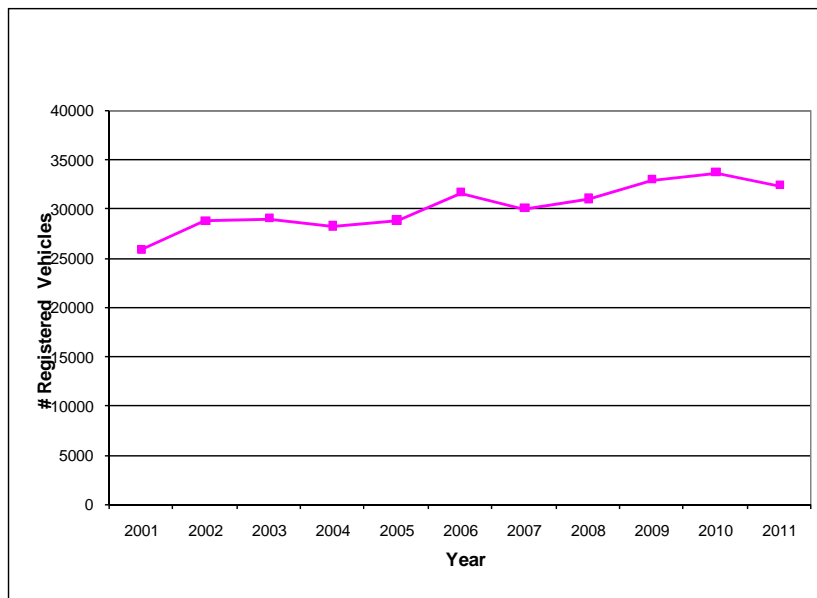

10. Trends in Revenue, 2001/2002 to 2011/2012



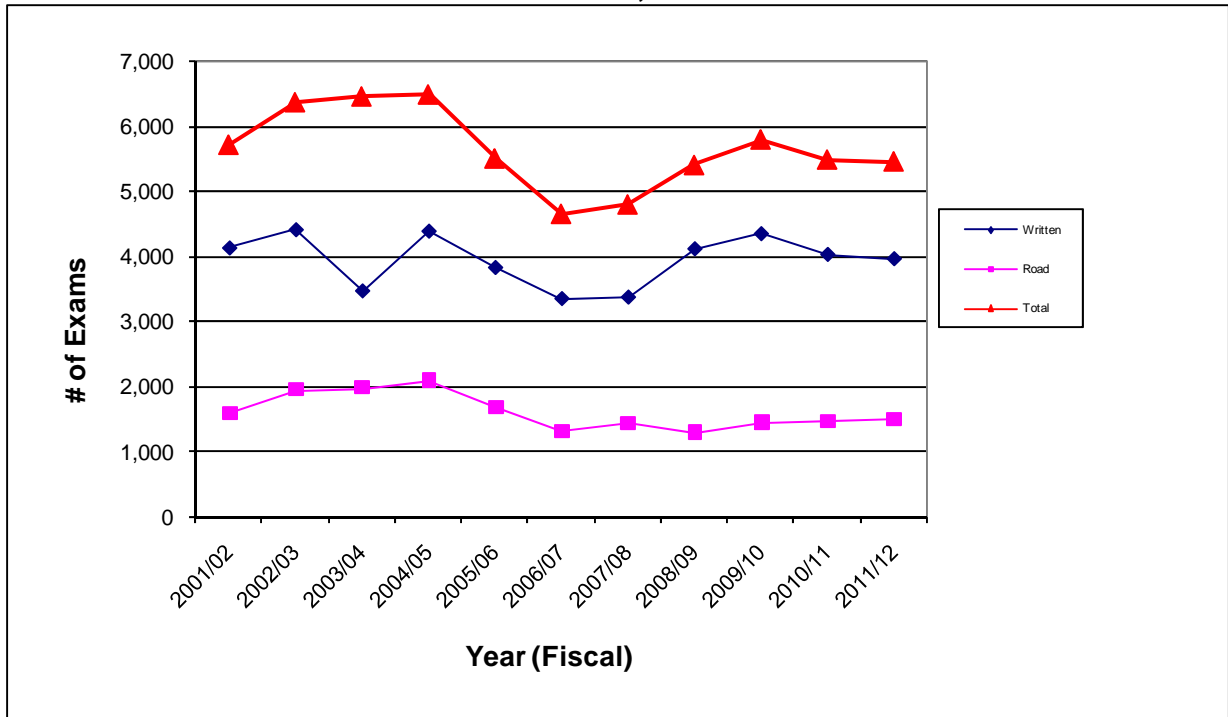

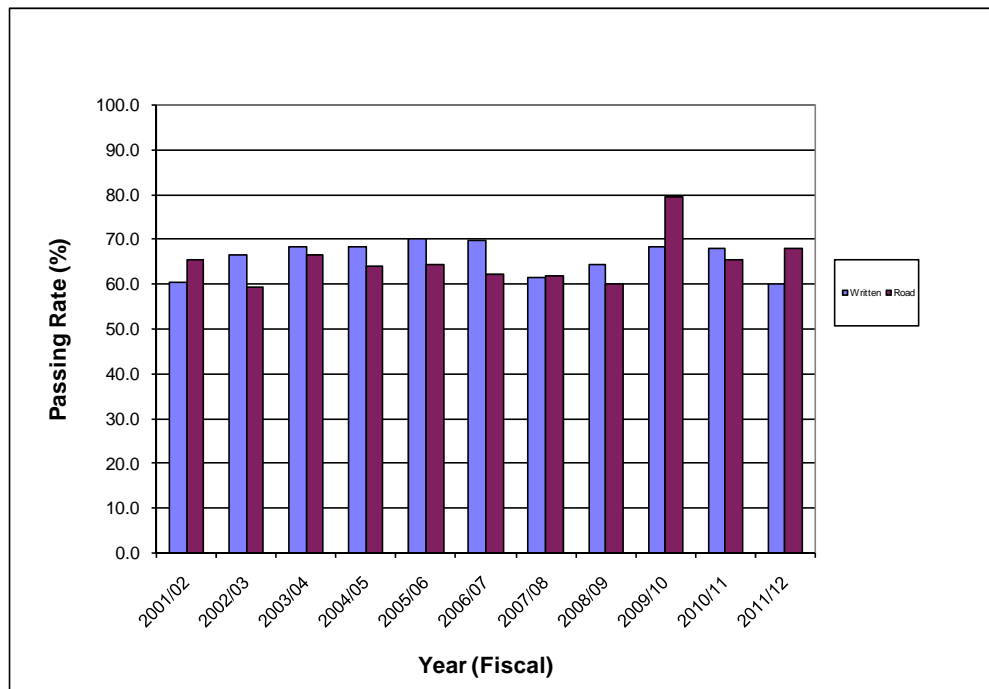

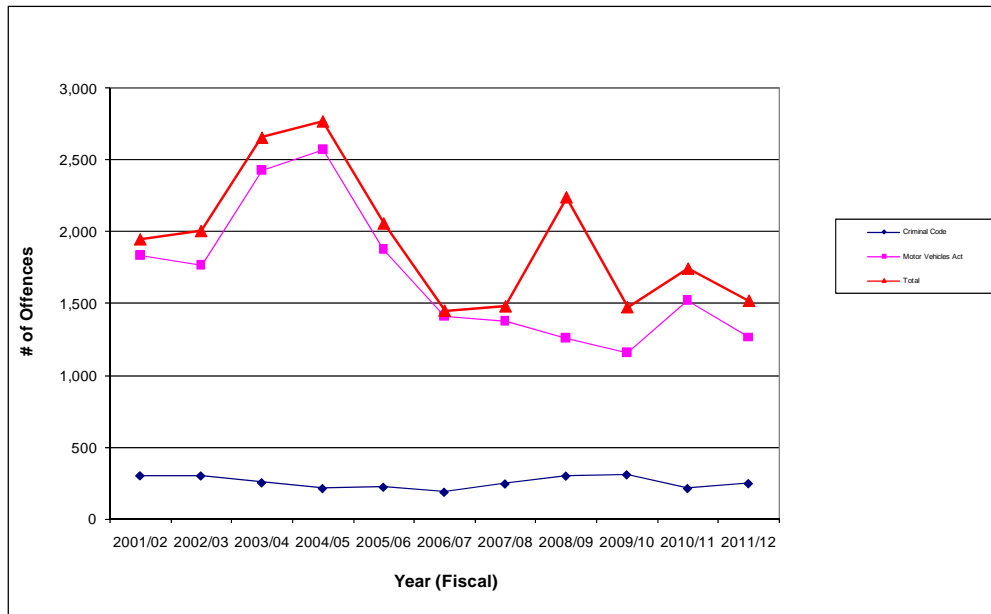
